OFFENSE DISORDERLY CONDUCT - INSULT, TAUNT	

Sunday July 11 at 12:49 PM Rick KRLICH (who was working across the street from his home) reported a person driving Ohio motorcycle 02QHU stopped on Creed (where according to KRLICH he has a surveillance camera) and was giving "the middle finger" for an extended time directly to that camera...the subject pulled forward to the stop sign and KRLICH recorded the license plate number as KRLICH was driving back from across the street...the subject then allegedly gave KRLICH an extended middle finger, then, drove off.

When KRLICH filed the police report a person is on a photo from KRLICH's tape, indeed "giving the middle finger" to KRLICH's camera.
