Monday February 20, 2012 Police Chief TAAFE advised reporting Sergeant to receive complaints from Mr KRLICH, 713 East Liberty Street and to complete an Incident report for each occurrence...attempt to identify the driver of this vehicle by sight from Mr KRLICH's surveillance video...then forward any applicable information to the follow up Officer to contact the vehicle's registered owner.

Several days later, on or about Wednesday February 22 I contacted Mr KRLICH and advised him I'd received an assignment from the Chief to receive his complaints of the peace being disturbed by subject (s) "blowing their horn".

I asked Mr KRLICH if there are occurrences of "horn blowing" to put everything together (his notes and surveillance video) and bring all of the information to the police department.

This alleged occurrence was on Tuesday, April 17 @ 5:08 PM...it was reported to the police that same day @ 9:53 PM.

Mr KRLICH alleged Ohio CE10LD _____ drove by and honked the horn, and, that _____ is a 'repeater' (having done this in the past ?)

Mr KRLICH had provided a surveillance CD and I reviewed it...at 5:08:15 a _____ displaying license plate CE10LD, with what appears to a lawn mower sticking out of the trunk drives westbound on East Liberty and the horn is blown apparently by the operator of the vehicle as it approaches Creed...the horn is blown "for a second or two...but not for an excessively long time". As the horn is blown, observed on the corner of Creed @ East Liberty (on the sidewalk) is _____ of Creed along with his _____ and their dog... turns towards the street and waves at _____

The license plate CE10LD is _____

It is not possible to see on the surveillance CD who was driving.

This Incident is Closed at this time...with _____ observed waving at "the horn blowing car" there does not appear to be criminal intent. The surveillance CD placed in an envelope and attached to the file copy of the Incident report.
