Monday February 20, 2012 Police Chief TAAFE advised reporting Sergeant to receive complaints from Mr KRLICH, 713 East Liberty Street and to complete an Incident report for each occurrence...attempt to identify the driver of this vehicle by sight from Mr KRLICH's surveillance video...then forward any applicable information to the follow up Officer to contact the vehicle's registered owner.

Several days later, on or about Wednesday February 22 I contacted Mr KRLICH and advised him I'd received an assignment from the Chief to receive his complaints of the peace being disturbed by subject (s) "blowing their horn."

I asked Mr KRLICH if there are occurrences of "horn blowing" to put everything together (his notes and surveillance video) and bring all of the information to the police department.

This alleged occurrence was on Tuesday, April 17 @ 4:38:10 PM and was reported to the police department that same day @ 9:53 PM...Ohio BX26JK reportedly blew it's horn.

A surveillance CD was provided by Mr KRLICH and I reviewed it...04-17-12 @ 4:38:10 PM a tan 4 door Mercury full size car is observed eastbound on East Liberty, passing Creed, and the horn is blown for no apparent reason...there is no road hazard or animal on the road observed, and there is no other traffic in sight.

Marked on Mr KRLICH's CD along with 04-17-2012 is May 11, 2011 @ 3:34:57 PM...I viewed that segment which showed Ohio BX26JK eastbound on East Liberty, pass Creed, and blow the horn twice for no apparent reason...there was no other traffic and there were no road hazards observed.

It is not possible to see from the surveillance CD who was driving.

Ohio BX26JK is registered to William VRABEL, 721 Penhale Avenue, Campbell OHIO 44405.

VRABEL's name was checked through the RMS data...VRABEL's name does not appear in anything besides a Call for Service made in May 2011 by Mr KRLICH.

The surveillance CD was placed in an envelope and attached to the file copy of the Incident report.

The Incident report is cleared as "Investigation Pending" as forwarded to the follow up Officer.
