Monday February 20, 2012 Police Chief TAAFE advised reporting Sergeant to receive complaints from Mr KRLICH, 713 East Liberty and to complete an Incident report for each occurrence...attempt to identify the driver of this vehicle by sight from Mr KRLICH's surveillance video...then forward any applicable information to the follow up Officer to contact the vehicle's registered owner.

Several days later, on or about Wednesday February 22 I contacted Mr KRLICH and advised him I'd received an assignment from the Chief to receive his complaints of the peace being disturbed by subject (s) "blowing their horn."

I asked Mr KRLICH if there are occurrences of "horn blowing" to put everything together (his notes and surveillance video) and bring all of the information to the police department.

This alleged occurrence was on Thursday April 26 @ 4:10:27 PM...(and was reported to police on Saturday April 28)...Mr KRLICH wrote Ohio DFM8739) on the

surveillance CD...upon viewing that surveillance CD, obviously did not "blow the horn".. turns off of East Liberty (eastbound) onto Creed and the operator of this vehicle seemingly "blows the horn"...there is no camera view of Creed (beyond the intersection) shown so it is unknown if there is any road hazard up ahead on Creed for this vehicle....a follows this onto Creed...then follows the onto Creed...then which was behind these vehicles eastbound on Liberty continues eastbound on East Liberty...no horn is blown.

Mr KRLICH attached 2 other segments to this CD...apparently alleging 2 other occurrences of "horn blowing" by this vehicle.

07-18-2011 @ 8:03:42 AM Ohio DFM8739 is observed traveling very slow westbound on East Liberty with 2 other cars right behind it..

is seen turning onto Creed from East Liberty (apparently westbound on Liberty, then onto Creed)...then a horn is blown...whether it is from or the other cars, it is unknown...but it is obvious the 'horn was blown' by a frustrated motorist or a motorist that felt some traffic or safety offense was committed by
