Monday February 20, 2012 Police Chief TAAFE advised reporting Sergeant to receive complaints from Mr KRLICH, 713 East Liberty Street and to complete an Incident report for each occurrence...attempt to identify the driver of this vehicle by sight from Mr KRLICH's surveillance video...then forward any applicable information to the follow up Officer to contact the vehicle's registered owner.

Several days later, on or about Wednesday February 22 I contacted Mr KRLICH and advised him I'd received an assignment from the Chief to receive his complaints of the peace being disturbed by subject 9s0 "blowing their horn."

I asked Mr KRLICH if there are occurrences of "horn blowing" to put everything together (his notes and surveillance video) and bring all of the information to the police department.

This alleged occurrence was on Thursday April 19 @ 07:35...it was reported to police the same day @ 16:59 hours...Mr KRLICH reports 641YGL honked its' horn as it drove past Mr KRLICH's house.

Ohio 641YGL

As of this date and time...Monday April 23 @ 01:30 no surveillance CD has been produced by Mr KRLICH...in light of that, Incident Closed at this time.

ADDENDUM : Upon reporting for duty Saturday April 28, a surveillance CD was found in my mailbox...I viewed the CD and observed 641YGL turn from eastbound on East Liberty south onto Creed with a date/time marked as 04-19-12 7:34:34 AM and heard a horn blow ...it is not possible to observe what was ahead of this vehicle and once the vehicle travels down Creed.

It is not possible to see on the surveillance Cd who is actually driving the vehicle.

It was my intention to refer this to the follow up Officer...however...upon reporting for duty Monday night April 30 th, Officer THIRION said " we talked about that complaint last night and tonight before work was sitting right next to me at a baseball game...I advised of the complaint and right away said " I knew it...I remember it all right because a squirrell was in the road and wouldn't move...it was a nice day and I just didn't want to hit and

On 4-29-2012 Sgt. Fisher and I (Ptl. Thirion) were speaking about the new cases that Mr. Krllich had dropped off at the PD. Sgt. Fisher stated that one of the CDs was from a report that he had already done. He stated that it was in reference to [redacted] and he asked Dispatcher Lavelle if she could check and see if he had already done an incident.

Dispatcher Lavelle came back to his office and advised him that he had already done an incident in reference to [redacted] from that date. Sgt. Fisher and I watched the CD in that was supplied by Mr. Krllich. You could see the vehicle turn right off of East Liberty street and head down Creed Ave. You then heard two (2) quick beeps of the horn. Shortly after that, you could faintly hear what appeared to be two (2) more quick beeps. Sgt. Fisher then stated that he had closed it but would have someone speak with [redacted] and advise [redacted] of the complaint.

On 4-30-2012 I saw [redacted] at Harding Park. I asked [redacted] if anyone had spoken with [redacted] from the Police Department in reference to [redacted] beeping [redacted] horn. [redacted] stated that no one had spoken with [redacted] did advise me that [redacted] knew what I was talking about though. [redacted] stated that the other day when [redacted] was going home [redacted] beeped [redacted] horn while on Creed Ave. [redacted] stated that there was a squirrel on the roadway and that [redacted] did not want to strike it. [redacted] said that [redacted] did not excessively honk [redacted] horn and that [redacted] was only trying to get the animal to move. [redacted] said that when it did not leave the roadway [redacted] honked again.

[redacted] then stated that [redacted] knew that something was going to happen. [redacted] said that [redacted] ran home to grab something (I believe [redacted] stated [redacted] wallet) and then went straight back to [redacted] vehicle to leave. As [redacted] was leaving [redacted] driveway, saw Mr. Krllich driving slowly past the bottom of [redacted] drive. [redacted] said that [redacted] just continued on [redacted] way because [redacted] had somewhere to be. [redacted] stated that [redacted] did tell [redacted] to whom [redacted] resides with [redacted] stated that [redacted] was very upset that Mr. Krllich followed [redacted] home.
