Monday February 20, 2012 Police Chief TAAFE advised reporting Sergeant to receive complaints from Mr KRLICH, 713 East Liberty Street and to complete an Incident report for each occurrence...attempt to identify the driver of this vehicle by sight from Mr KRLICH's surveillance video...then forward any applicable information to Officer PORTER for him to contact the vehicle's registered owner for a follow up."

Several days later, on or about Wednesday February 22 I contacted Mr KRLICH and advised him I'd received an assignment from the Chief to receive his complaints of the peace being disturbed by subject (s) "blowing their horn."

I asked Mr KRLICH if there are occurrences of "horn blowing" to put everything together (his notes and surveillance video) and bring all of the information to the police department.

This Incident involves a black / green Jeep, Ohio registration EOX7308 which is registered to _____ This Jeep is familiar to me and is typically operated by _____

Mr KRLICH alleges this Jeep and its driver's actions are "Menacing by Stalking".

Reporting Sergeant completed the report for "Disturbing the Peace of the Neighborhood MM".

Mr KRLICH provided a surveillance CD (of EOX7308) with 5 segments:

1. 05-20-2011 @ 9:53 PM Jeep observed eastbound on East Liberty and passing Mr KRLICH's house...the Jeeps top is off and Mr KRLICH reports they're yelling "Fuck You". I listened to CD several times...there is some yelling but I can't hear what is yelled.

2. 06-20-2011 @ 8:58 PM Jeep observed eastbound on East Liberty then turns South onto Creed...Mr KRLICH reports they yell "ass hole"...I listened to CD several times...there is some yelling but I can't hear what is yelled.

3. 06-24-2011 @ 8:56:42 PM Jeep is eastbound on East Liberty, turns South onto Creed and Mr KRLICH reports "yelling and the middle finger given"...I listened and watched several times...there is some shrieking or screaming but I can't hear what is yelled. I cannot see anybody giving the middle finger.

4. 06-27-2011 @ 6:04 PM Jeep is eastbound on East Liberty and turns South onto Creed...Mr KRLICH reports they're yelling "Fuck You"...I watched and listened to the CD several times and there was some yelling but I can't hear what is yelled.

5. 03-02-2012 @ 8:21 PM Jeep is observed on Creed north bound to East Liberty Street...Mr KRLICH reports they're yelling "Ya Ya" and racing the engine...I viewed the CD several times and did not hear anything yelled...the driver pulls out onto East Liberty and is observed going down the hill, accelerating hard and revving engine...but...this revving does not rise to the threshold of a crime of disturbing the peace being committed.

I reviewed and printed out "Menacing by Stalking 2903.211" and none of the elements seem to fit.

It is NOT possible to see who is operating the Jeep, or identify the driver from Mr KRLICH's surveillance CD.

This Incident is "Investigation Pending" and referred to Officer PORTER ... the Jeep driver could be advised of the complaint and asked, in the spirit of keeping the peace, for himself and his passengers to refrain from yelling in the area of Mr KRLICH's residence.

The surveillance CD was placed in an envelope and attached to the file copy of the Incident report.
