Monday February 20, 2012 Police Chief TAAFE advised reporting Sergeant to "recieve complaints from Mr KRLICH, 713 East Liberty Street and to complete an Incident report for each occurrence...then attempt to identify the driver of this vehicle by sight from Mr KRLICH's surveillance video...and forward any applicable information to Officer PORTER for him to contact the registered owner for follow up."

Several days later, on or about Wednesday February 22 I contacted Mr KRLICH and advised him I'd recieved an assignment from the Chief to recieve his complaints of the peace being disturbed by subject (s) blowing their horn.

I asked KRLICH if there were any subjects whom he noted as "blowing their horn" over the past month or so, to put everything together (his notes and surveillance video with the dates and times noted) and bring it all down so I can begin the assignment by starting a ledger listing each occurrence.

Sunday February 26 Mr KRLICH brought in some 24 notepads he reported as "horn blowing" over the past month to 6 weeks or so.

This alleged occurrence was on Tuesday February 14 @ 4:15:47 AM ...Mr KRLICH advised it was a gray Jeep with Ohio license plate FEC2832 which

Mr KRLICH provided a surveillance CD of this occurrence but the driver could not be seen or ID'ed by viewing it...the Jeep turns off of East Liberty Street onto Creed and the horn is blown.

I am familiar with and know the usual operator of this Jeep,

A phone call was made to the residence asking that contact me regarding a complaint. Monday, March 5, 2012 @ 1:21 AM (after also speaking with and explaining the nature of the complaint to came in to see me after getting

When asked, said "I'm the only one who drives the Jeep."

The surveillance CD provided by Mr KRLICH was shown to the operator could not be seen on the CD...also included on the CD was an instance from December of 2011 that showed the gray Jeep FEC2832 blow the horn and make a hand motion at the stopped car in front of him on Creed. called
