This 21st day of November, 2007 this cause came on to be heard upon the Complaint of the Plaintiff, the Answer of Defendant thereto, the Complaint filed by Garrick Krlich, the Answer of Defendant thereto, and the Motion to Set Aside Order of Sale filed by Garrick Krlich, the Court being fully advised in the premises, finds that the Order of Private Sale was issued on July 31, 2007 and that the Motion to Set Aside the Order of Sale was filed on November 20, 2007, and is untimely.
